

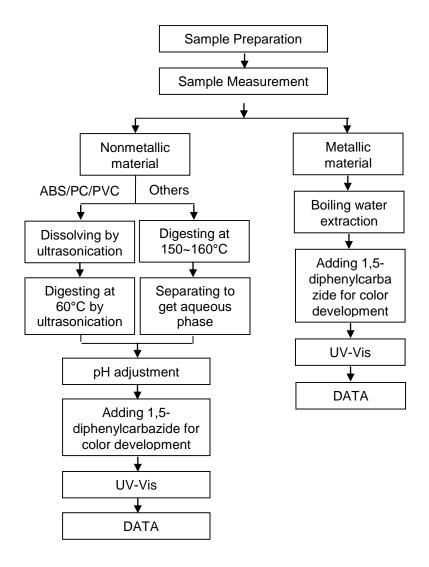



### **PBB/PBDE Testing Flow Chart**










